Tenders will be evaluated on 80/20points system in line with Nkomazi municipality Supply Chain Management Policy.

Only tenderers who attended the above meeting shall be considered and no tenderer shall be allowed into the meeting venue and/or to sign the attendance register without being part of the meeting.


Completed bid documentation must be deposited **on/before 12h00 on 17/07/2018** in the Tender Box situated at the main entrance of the municipality (Civic Centre), 9 Park Street Malalane.

Tenders/Bids must be submitted in a sealed envelope or container on which the tender/bid number and addressee is clearly marked. No bids transmitted by fax or e-mail will be accepted. It must be noted that the municipality is not bound to accept the lowest on any other tender.

Tender/bid documentation which is incomplete or filled incorrectly, not filled in on the official bid documentation or which is received after the close of the bids, will be ignored. It must also be noted that tender submitted in a wrong tender box will not be considered. Nkomazi Local Municipality supports empowerment of the previously disadvantaged, and SMME's.

Bidders will be evaluated on functionality whereby 60 points has to be attained before financial proposals can be looked at.
