
Only cash or bank guaranteed cheques will be accepted and cheques are to be made payable to Nkomazi Local Municipality.

The Nkomazi Municipality reserves the right to accept a tender as a whole or in part and does not bind itself to accept the lowest or any other tender.


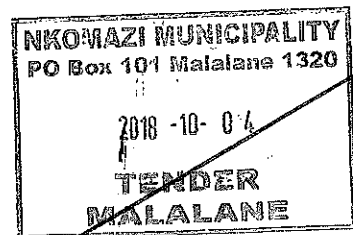
