
A compulsory tenderers briefing session will be held on **30/08/2018 at 10H00** at the Municipal Town Hall (Kobwa) at Fish Eagle. Tenderer who is 15 minutes late will not be allowed to enter the briefing boardroom. Only tenderers who attended the above meeting shall be considered and no tenderer shall be allowed into the meeting venue and/or to sign the attendance register without being part of the meeting.

Completed bid documentation must be deposited **on/before 12h00 on 21/09/2018** in the Tender Box situated at the main entrance of the municipality (Civic Centre), 9 Park Street Malalane.

Tenders/Bids must be submitted in a sealed envelope or container on which the tender/bid number and addressee is clearly marked. No bids transmitted by fax or e-mail will be accepted. It must be noted that the municipality is not bound to accept the lowest on any other tender.

Tender/bid documentation which is incomplete or filled incorrectly, not filled in on the official bid documentation or which is received after the close of the bids, will be ignored. It must also be noted that tender submitted in a wrong tender box will not be considered. Nkomazi Local Municipality supports empowerment of the previously disadvantaged, and SMME's.
