Bidders interested in this tender are reminded of the local content rules as stipulated in MBD 6.2 (Local content) as per the attached annexure in the document that car bodies to be supplied must be 80% and 100% respectively local manufactured.

Tenders/Bids must be submitted in a sealed envelope or container on which the tender/bid number and addressee is clearly marked. No bids transmitted by fax or e-mail will be accepted. It must be noted that the municipality is not bound to accept the lowest on any other tender
