Tenderers will be meeting next to the N4 opposite the entrance of the Mjejane Game Reserve, from where we will be moving to site. **High clearance vehicles will be required.**

A preferential point system shall apply whereby this contract will be allocated to a bidder in accordance with the **Preferential Procurement Policy Framework Act, No 5 of 2000** and as defined in the conditions of bid in the bid document, read in conjunction with the Preferential Procurement Regulations, 2017, where 80 points will be allocated in respect of price and 20 points in respect of B—BBEE status level of contribution.

The Tenderer must sub-contract a minimum of 30% to local sub—contractors as per Preferential Procurement Regulations (PPR) 2017, item 4(1)(c). Preference for sub—contracting will be given to youth, women, and cooperatives that are identified as local and reside within the municipality.


