The Nkomazi Local Municipality invites tenders for the construction of Mjejane Water Supply- phase 3 (Water reticulation network – Zone 2).

In terms of section 110 of the Municipal Finance Management Act 2003 (No 56 of 2003) tenders will be evaluated on 80/20 point system in line with the Nkomazi Municipalities Supply Chain Policy. Part of the condition of this tender is that the service providers attentions is drawn towards the requirement of MBD 6.2 (Local content) as per attached annexure in the document as such all steel product and components are 100% respectively local manufactured.

It is estimated that tenders should have a CIDB contractor grading of 7CE or higher. In the case of a Joint Venture every member of the Joint Venture should be registered with the CIDB and the lead partner should have a Contractor grading designation in the CE class of construction work. The combined Contractor grading designation calculated in accordance with Regulation 25 (18) of 25 (7A) of the Construction Industry Development Regulations shall be equal to or higher than a contractor grading designation of 7CE.

Bid documents will be obtainable from **14 July 2020** on payment of a cash, non-refundable fee of R1183.63 per document.
