Tenders will be evaluated on 80/20 points system in line with Nkomazi municipality Supply Chain Management Policy. Only tenderers who attended the above meeting site briefing shall be considered and no tenderer shall be allowed to sign the attendance register without being part of the meeting. Completed bid documentation must be deposited **on/before 12h00 on 15/03/2018** in the Tender Box situated at the main entrance of the municipality (Civic Centre), 9 Park Street Malalane. Tenders/Bids must be submitted in a sealed envelope or container on which the tender/bid number and addressee is clearly marked.

No bids transmitted by fax or e-mail will be accepted. It must be noted that the municipality is not bound to accept the lowest on any other tender. Tender/bid documentation which is incomplete or filled incorrectly, not filled in on the official bid documentation or which is received after the close of the bids, will be ignored.
