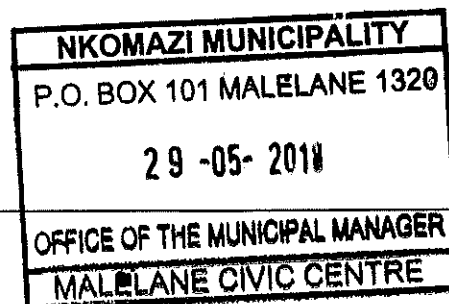
Tenders may only be submitted on the tender documentation that is issued. The **80/20** preferential procurement point system as outlined in the bid document will apply.
